#### What will OpenDataMonitor do?

OpenDataMonitor will deliver an analysis and visualisation platform giving insights into open data deployment across Europe.

#### and how?

By harvesting multilingual metadata from local, regional and national open data hubs across Europe into a dedicated instance of the CKAN software. Once harvested, a novel platform will provide analytics and visualisation capabilities on top of this data.

#### What analytical functions will it offer?

OpenDataMonitor will reveal patterns of open data deployment across Europe, looking at who, where, when and how data is being deployed. These analytics will help developers, entrepreneurs, policy makers and enthusiasts to understand how the open data ecosystem is evolving.

#### How is the project organised?

##### WP 1: Project Management

##### WP 2: Research studies and stakeholder analysis

Investigation of current open data topologies, catalogues, metadata harmonisation, innovative monitoring methods, architectures and standards, best practice data visualisation, dashboards and key figures

##### WP 3: Concept design and software development

Defining the exact technical specifications, and functionalities as well as detailed interface designs and dashboards for metadata harmonization & monitoring

##### WP 4: Demonstration and instructions

Deployment of the tool demonstrator, performing usability tests and undertaking feedback loops with selected end users to ensure an easy introduction to its usage

##### WP 5: Dissemination and exploitation

Utilizing a range of tools and networks to disseminate the outcomes of ODM to our identified community groups and users, including our website, project branding, media assets, publications, presentations and public events

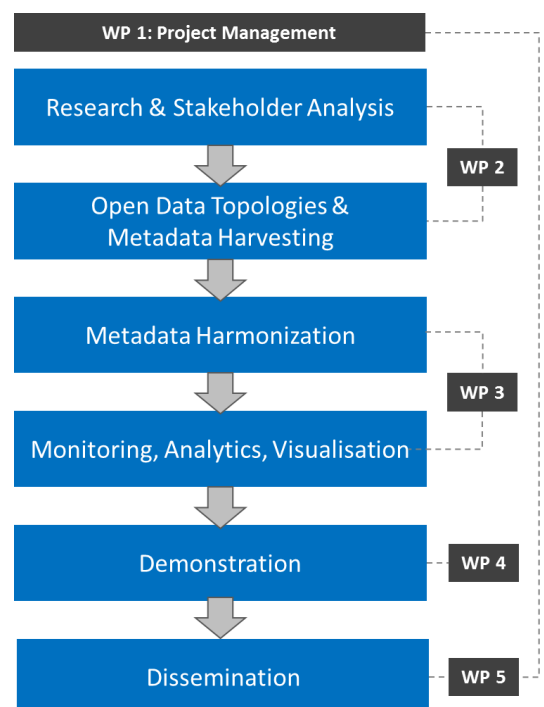
